By Petition filed on December 8, 2006, Quincy Telephone Company d/b/a TDS Telecom (TDS) has requested permission to intervene in this proceeding. TDS is an incumbent local exchange telecommunications company (ILEC) authorized by the Commission to provide local exchange service in the State of Florida. In the instant docket, Alltel Communications, Inc. (Alltel) has requested designation as an eligible telecommunications carrier (ETC) to serve certain areas of the state where TDS operates as a rural ILEC under Federal Communications Commission rules. In support of its Petition, TDS asserts that any decision made by this Commission in the context of this proceeding will necessarily affect TDS's substantial interests and its business operations in the State of Florida.

Having reviewed the Petition, it appears that TDS's substantial interests may be affected by this proceeding, because it provides incumbent local exchange service in areas of Florida where Alltel has requested designation as an ETC. Therefore, TDS's request for permission to intervene in this proceeding shall be granted. Pursuant to Rule 25-22.039, Florida Administrative Code, TDS takes the case as it finds it.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of the Commission Clerk and Administrative Services, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
