ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE  
POST-HEARING BRIEFS AND REVISING ORDER ESTABLISHING PROCEDURE

On February 8, 2008, Aqua Utilities, Florida, Inc. (AUF) filed an unopposed Motion for Extension of Time to File Post-Hearing Briefs (Motion). The current schedule calls for the parties to file post-hearing briefs on February 19, 2008.

AUF states that its lead counsel has a number of contemporaneous work commitments during the week before briefs are due in this case, including out of town meetings and preparation for appellate oral argument. AUF requests that the time for filing post-hearing briefs be extended by one week, to February 26, 2008, and represents that the other parties to this docket and staff do not oppose the Motion.

Upon consideration, AUF's Motion is granted. Order No. PSC-07-0777-PCO-WS, issued September 25, 2007, establishing procedure in this case, is hereby revised to reflect that that the parties' post-hearing briefs shall be due to be filed on February 26, 2008.

Based upon the foregoing, it is

ORDERED by Chairman Matthew M. Carter II, as Prehearing Officer, that AUF's Unopposed Motion for Extension of Time to File Post-Hearing Briefs is granted. It is further



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Office of Commission Clerk, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
