ORDER APPROVING APPLICATION FOR AMENDMENT OF CERTIFICATE
NOS. 076-W AND 284-S IN PUTNAM COUNTY BY AQUA UTILITIES FLORIDA, INC.
AND DECLINING TO INITIATE A SHOW CAUSE PROCEEDING

BY THE COMMISSION:

BACKGROUND

Aqua Utilities Florida, Inc. (AUF or Utility) is a Class A water and wastewater utility with 82 water and wastewater systems located in 16 counties throughout Florida. By Order Nos. 6236, issued August 19, 1974 (Interlachen Lakes Estates water), 7078, issued January 13, 1976 (Palm Port water and wastewater), and 23397, issued August 23, 1990 (Silver Lake Oaks water and wastewater), this Commission granted water and wastewater certificates for the above mention areas in Putnam County.¹ There have also been multiple certificate transfers and amendment activities that have occurred over the years (see Attachment A, pages 11-12 of 12). On August 12, 2008, the Utility filed an application with this Commission to amend Certificate Nos. 076-W and 284-S to add water and wastewater territory to certain service areas (three water systems and two wastewater systems) in Putnam County, pursuant to Section 367.045(2), Florida Statutes (F.S.).

Of AUF's Putnam County water and wastewater systems to be amended, the Utility provides service to approximately 435 water connections and 141 wastewater connections. This application was filed in response to a recent review of the Utility's service territory which revealed that the Utility is currently providing service to approximately 38 water connections and 7 wastewater connections located outside its certificated territory. The Utility is in the St. Johns River Water Management District. The Utility asserted that service to these residential customers began sometime between 1987 and 2003. AUF has indicated that a petition for certificate amendments to serve these customers was inadvertently overlooked.

The Utility determined that it was serving outside of its certificated area during the pendency of AUF's 2006 rate case in Docket No. 060368-WS. Shortly after the Utility obtained notice that it was serving outside of its territory, AUF filed this application for amendment of Certificate Nos. 076-W and 284-S to extend water and wastewater service to include those customers outside of the Utility's service territory that AUF is already providing service to. In addition to the existing connections in the amended areas, some of the proposed territories include lands which are expected to be further developed. The proposed amended areas are contiguous to AUF's existing Commission-approved service territory. We have jurisdiction pursuant to Section 367.045, F.S.

DECISION

Declining to Initiate a Show Cause Proceeding

As stated in the case background, AUF is serving customers outside of its certificated territory. Section 367.045(2), F.S., states in pertinent part: "A utility may not delete or extend its service outside the area described in its certificate of authorization until it has obtained an amended certificate of authorization from the [C]ommission" If a utility is found to have knowingly refused to comply with, or to have willfully violated any provision of Chapter 367, F.S., Section 367.161(2), F.S., authorizes this Commission to assess a penalty of not more than \$5,000 for each offense. By serving customers outside of its certificated territory without obtaining an amended certificate of authorization, the Utility's act was "willful" within the meaning of Section 367.161, F.S. In Order No. 24306, issued April 1, 1991, in Docket No. 890216-TL, In Re: Investigation Into The Proper Application of Rule 25-14.003, Florida Administrative Code, Relating To Tax Savings Refund For 1988 and 1989 For GTE Florida, Inc., having found that the company had not intended to violate the rule, we nevertheless found it appropriate to order it to show cause why it should not be fined, stating that "[i]n our view, 'willful' implies an intent to do an act, and this is distinct from an intent to violate a statute or rule"; see also Order No. PSC-99-2390-FOF-WU, issued on December 7, 1999, in Docket No. 980543-WU, In Re: Application for amendment of Certificate No. 363-W to add territory in Marion County by Sunshine Utilities of Central Florida, Inc. (finding that the utility's apparent violation of Section 367.045, F.S., did not warrant the initiation of a show cause proceeding).

Although AUF's failure to obtain amended certificates of authorization for its Interlachen/Park Manor, Palm Port, and Silver Lake Oaks systems in Putnam County from this Commission prior to serving outside of its certificated area is an apparent violation of Section 367.045(2), F.S., according to its application, the Utility erroneously believed that the territory in

question was included in its service area. When the error was discovered, AUF filed the instant application to correct the mistake and include the territory to its service area. The Utility has indicated that throughout this time period, the calculation of the annual regulatory assessment fees (RAFs) for AUF was inclusive of all these customers.

Thus, we do not believe that the apparent violation of Section 367.045, F.S., rises in these circumstances to the level which warrants the initiation of show cause proceedings. Therefore, we decline to initiate show cause proceedings for AUF's apparent failure to obtain an amended certificate of authorization prior to serving outside of its certificated territory.

Amendment of Certificate Nos. 076-W and 284-S

This application is in compliance with the requirements contained in Section 367.045, F.S., and Rule 25-30.036, Florida Administrative Code (F.A.C). The application contains proof of compliance with the noticing provisions set forth in Rule 25-30.030, F.A.C. No objections to the application have been received and the time for filing such objections has expired.

We find that the Utility has demonstrated its ability to serve the proposed extended areas and that it has the necessary financial and technical expertise to do so. In addition, the Utility has indicated that its current water and wastewater systems have sufficient capacity to serve the proposed area.

We have contacted the Department of Environmental Protection and learned that there are no outstanding notices of violation issued for AUF's water and wastewater treatment facilities. The Utility also provided verification of deeds to the water and wastewater treatment plant sites. Adequate service territory maps and territory descriptions have also been provided. Description of the proposed territories and a list of orders identifying AUF's authorized service territories are appended to this recommendation as Attachment A. The Utility has filed revised tariff sheets incorporating the additional territories into its tariff. However, these tariff sheets are still incomplete and further revision is necessary. The Utility shall have an additional 30 days from the date of this order approving the amendment to file revised tariff sheets that incorporate the additional territories. The Utility is currently providing service to approximately 38 water connections and 7 wastewater connections located outside its certificated territories. AUF has indicated that service to these residential customers began sometime between 1987 and 2003. The areas to be amended are to be included within the service areas of the Utility's Interlachen Estates, Palm Port, and Silver Lake Oaks water systems, as well as the Palm Port and Silver Lake Oaks wastewater systems. The Utility has indicated that throughout this time period, the calculation of the annual RAFs for AUF was inclusive of all of these customers.

Based on the foregoing, we find that it is in the public interest to approve the application filed by AUF to amend its territories to reflect areas described in Attachment A. Composite territory descriptions which reflect the combined existing and amended areas are also included in Attachment A. This order shall serve as AUF's amended certificates and shall be retained by the Utility. AUF shall charge the customers in the territories added herein the rates and charges contained in the current tariff until authorized to change by this Commission. In addition, the

Utility shall file revised tariff sheets that incorporate the additional territories within 30 days from the date of this Order.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that a show cause proceeding shall not be initiated. It is further

ORDERED that Aqua Utilities Florida, Inc.'s application to amend Certificates 076-W and 284-S to include territories as reflected in Attachment A, is approved. It is further

ORDERED that this Order shall serve as Aqua Utilities Florida, Inc.'s amended certificates and shall be retained by the Utility. It is further

ORDERED that the existing charges contained in its tariff shall be applied to the customers in the new territory until Aqua Utilities Florida, Inc. is authorized by this Commission to change them in a subsequent proceeding. It is further

ORDERED that Aqua Utilities Florida, Inc. shall file revised tariff sheets that incorporate the additional territory within thirty (30) days from the date of this Order. It is further

ORDERED that this docket shall be closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Office of Commission Clerk, and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
