ORDER CANCELING SHARED TENANT SERVICES CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Four Points Utility Corporation, holder of Shared Tenant services (STS) Certificate of Public Convenience and Necessity No. 8657, has requested the cancellation of STS Certificate No. 8657. Four Points Utility Corporation has complied with the provision of Rule 25-24.735(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its STS certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2009. Accordingly, we find it appropriate to cancel STS Certificate No. 8657, effective March 5, 2009. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.
