## ORDER AUTHORIZING MAINTENANCE OF ACCOUNTING RECORDS OUTSIDE THE STATE

## BY THE COMMISSION:

On April 11, 2013, pursuant to Rule 25-30.110(1)(b), Florida Administrative Code (F.A.C.), Silver Fox Utility Company, LLC (Silver Fox or Utility), now owned by Hometown Canada Utility, Inc., filed a request that the Commission authorize the Utility to maintain its accounting records at the Utility's parent offices in San Bruno, California. Silver Fox stated that maintaining the accounting records at the parent office will permit more efficient and cost-effective service and reduce duplication of expenses. Customer billing records will be maintained at the Utility's location in Florida. Through an administrative recommendation filed on June 4, 2013, the Commission staff has recommended that Silver Fox's request be approved. The Utility will make its out-of-state records available to staff electronically upon request. Silver Fox understands and will comply with the requirements of Rule 25-30.110(1)(c), F.A.C., regarding reimbursements of travel expenses associated with Commission staff travel to review Utility records located outside of Florida, if records cannot be provided electronically.

We hereby grant Silver Fox Utility Company, LLC's request to maintain accounting records out-of-state, pursuant to Rule 25-30.110(1)(b), F.A.C. We have jurisdiction pursuant to Section 367.121(1)(k), Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Silver Fox Utility Company, LLC's request for authorization to maintain accounting records outside of the state of Florida, pursuant to Rule 25-30.110(1)(b), Florida Administrative Code, is hereby granted, It is further

ORDERED that this docket shall remain open.

Any party adversely affected by the Commission's final action in this matter may request:

1) reconsideration of the decision by filing a motion for reconsideration with the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Office of Commission Clerk, and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
