FINAL ORDER APPROVING PURCHASED GAS ADJUSTMENT TRUE-UP AMOUNTS  
AND ESTABLISHING PURCHASED GAS COST RECOVERY FACTORS TO BE APPLIED  
DURING THE PERIOD JANUARY 2015 THROUGH DECEMBER 2015

BY THE COMMISSION:

As part of our continuing purchased gas adjustment true-up proceedings, an administrative hearing was held October 22, 2014, in this docket. Florida City Gas, Florida Public Utilities Company, Peoples Gas System, and St. Joe Natural Gas Company submitted testimony and exhibits in support of their proposed final and estimated true-up amounts and their proposed purchased gas recovery factors. The Office of Public Counsel (OPC) also participated in this proceeding. Prior to the hearing, the parties reached agreement concerning all issues identified for resolution at hearing. These issues were presented to us as a stipulation. We have jurisdiction over the subject matter by the provisions of Chapter 366, Florida Statutes (F.S.), including Sections 366.04, 366.05, and 366.06, F.S.

The parties stipulated to the final and estimated true-up amounts and purchased gas cost recovery factors appropriate for each utility. We accept and approve the stipulations as reasonable and supported by competent, substantial evidence of record as set forth below.

We find that the appropriate final purchased gas adjustment true-up amounts for the period January 2013 through December 2013 are as follows:

| Florida City Gas                 | \$1,332,078 | Over-recovery  |
| Florida Public Utilities Company | \$95,276    | Over-recovery  |
| Peoples Gas System               | \$3,036,213 | Under-recovery |
| St. Joe Natural Gas Company      | \$10,765    | Under-recovery |

We find that the appropriate actual/estimated purchased gas adjustment true-up amounts for the period January 2014 through December 2014 are as follows:

|                                  |             |                |
|----------------------------------|-------------|----------------|
| Florida City Gas                 | \$1,069,341 | Under-recovery |
| Florida Public Utilities Company | \$728,413   | Over-recovery  |
| Peoples Gas System               | \$3,655,983 | Over-recovery  |
| St. Joe Natural Gas Company      | \$7,925     | Over-recovery  |

We find that the appropriate total purchased gas adjustment true-up amounts to be collected during the period January 2015 through December 2015 are as follows:

|                                  |           |                |
|----------------------------------|-----------|----------------|
| Florida City Gas                 | \$262,737 | Over-recovery  |
| Florida Public Utilities Company | \$823,689 | Under-recovery |
| Peoples Gas System               | \$619,770 | Over-recovery  |
| St. Joe Natural Gas Company      | \$2,840   | Under-recovery |

We find that the appropriate levelized purchased gas cost recovery (cap) factors for the period January 2015 through December 2015 are as follows:

|                                  |                        |
|----------------------------------|------------------------|
| Florida City Gas                 | 88.283 cents per therm |
| Florida Public Utilities Company | 98.747 cents per therm |
| Peoples Gas System               | 98.354 cents per therm |
| St. Joe Natural Gas Company      | 74.10 cents per therm  |

We find that these factors shall be effective for all meter readings on or after January 1, 2015, beginning with the first or applicable billing cycle for the period January 2015 through December 2015.


Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the stipulations, findings, and rulings set forth in the body of this Order are hereby approved. It is further

ORDERED that each utility that was a party to this docket shall abide by the stipulations, findings, and rulings herein which are applicable to it. It is further

ORDERED that the utilities named herein are authorized to collect the purchased gas adjustment amounts and utilize the factors approved herein effective with all meter readings on or after January 1, 2015, beginning with the first or applicable billing cycle for the period January 2015 through December 2015.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request:

- 1) reconsideration of the decision by filing a motion for reconsideration with the Office of Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or
- 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Office of Commission Clerk, and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
