AMENDATORY ORDER

On April 13, 2016, GigaMonster, LLC submitted an application for a certificate to provide local telecommunications service in Florida. On August 31, 2016, a consent recommendation was filed with the Office of Commission Clerk recommending approval of GigaMonster's application for a Certificate of Authority. On September 13, 2016, GigaMonster's application for certificate to provide local telecommunications in Florida was approved by the Commission.

On September 19, 2016, we issued Order No. PSC-16-0381-PAA-TX Granting Certificate of Authority No. 8889 to GigaMonster, LLC. Following the expiration of the protest period on October 14, 2016, we issued Consummating Order No. PSC-16-0465-CO-TX to acknowledge that Order No. PSC-16-0381-PAA-TX had become effective and final. However, due to a scrivener's error, Order Nos. PSC-16-0381-PAA-TX and PSC-16-0465-CO-TX reflects Certificate No. 8889 instead of Certificate No. 8891 as GigaMonster's assigned Certificate number. Accordingly, Order Nos. PSC-16-0381-PAA-TX and PSC-16-0465-CO-TX are amended to correct the scrivener's error outlined above and amended to reflect Certificate No. 8891 as GigaMonster's assigned Certificate number. Order Nos.
