7.12.1 ABN Advantage Plan*

Customers may commit to take service for terms of 1, 2, 3, 4 or 5 year term commitments available to ABN Advantage Plan customers.

ABN Advantage Plan has two rate plans depending on the customer's Revenue Commitment under the ABN Advantage Plan long distance service as specified below:

Plan A - Revenue Commitment between \$2500 and \$69,999

Plan B - Revenue Commitment \$70,000 and above

Pricing will vary by plan and term commitment, as specified in the RATE SCHEDULE.
