Sprint Up Sell Promotion I

Customers subscribing to this promotion will receive a \$16.67 credit each month for up to three months starting with their first full month's invoice. Unused credit may not be carried over to another month. Customers may not subscribe to any other promotion. This promotion is available for enrollment through December 31, 2004, unless sooner changed or cancelled by Sprint.

Sprint/RadioShack 500 Minute Prepaid PhoneCard Promotion
