A13.4 AT&T TRUE TIES CALLING PLAN (T)  
(ATYT SelectCall Plan)

A13.4.1 General (T)

This plan is an AT&T Long Distance Service that permits the customer to receive direct dialed calls originated over the AT&T network from subscriber-authorized telephone numbers and have those calls automatically reverse-billed to the customer without the assistance of a Company operator. The customer must supply AT&T with the specific telephone numbers (up to a maximum of five) that are to be authorized. The terms and conditions of this plan are specified and contained in the AT&T Consumer Service Guide OTH01001DD. (T)

A13.4.2 Availability of Service (T)

This plan is available to customers in equal access areas of Local Exchange Companies where the required billing capability exists, as specified in the AT&T Consumer Service Guide OTH01001DD. (T)

AT&T True Ties Calling Plan is available on direct dialed calls. It is not available on the following types of calls: (T)

Operator Handled (collect, third number, person-to-person, calling card, real time rated),  
Customer Dialed Calling Card,  
Conference Calls.

A13.4.3 Regulations (T)

This plan includes a Service Charge per call. Usage charges for calls are Dial Station rates as specified in the Message Telecommunications Services Tariff and are included in discounts under AT&T Optional Calling Plans specified in Section A3 of this tariff. (T)

Charges for Eligible Card calls billed under this optional plan will not be further discounted by any other AT&T plan or promotion unless explicitly stated otherwise. Eligible Card calls will also be excluded when determining the applicable discount level a Customer qualifies for when subscribed to certain plans.

The Customer's Dial Station calls, Operator-handled calls, and non-eligible Calling Card calls will be rated in accordance with the specific rate plan or promotional offer to which the Customer is subscribed.

A13.12.3 Limitations

This plan is not available to Customers subscribing to any other AT&T Calling Card Plan or promotion unless specifically indicated otherwise. Usage from conference calls, 900 Services, AT&T 500 Personal Number Service, AT&T EasyReach Service, AT&T 800 Plan P Service, calls to Directory Assistance, calls billed to a LEC calling card, calls billed to a commercial credit/charge card, AT&T DIRECTORY LINK Service calls, mobile, marine, or cellular services, and all Calling Card calls that are not placed via 1-800-CALLATT (or other specific number so designated by AT&T) are excluded from this plan,
