Frame Migration to NetVPN Promotion

OVERVIEW OF PROMOTION:

BellSouth plans the following Frame Migration to NetVPN Promotion that will begin on October 3, 2005 and end on December 31, 2005. Standard termination liability charges associated with Frame Relay service circuits will not be applicable for qualifying subscribers who sign a twenty-four (24) month or longer agreement for a BellSouth NetVPN service circuit as a replacement for a Frame Relay service circuit which has been installed for twelve (12) months or longer.

PROMOTION SPECIFICS:
