EXECUTIVE SUMMARY

The purpose of this filing is to add clarifying regulations to an existing promotion for BellSouth Primary Rate ISDN provided in Section A2 of the General Subscriber Services Tariff. Regulations were added to clarify that termination liability in Section A42.3 will apply following the 90-day Satisfaction Guarantee period.
