Centrex Add a Line

Overview

The Centrex Add a Line promotion is scheduled to begin 1/1/2009 through 4/30/2009. This promotion provides existing Centrex and Centrex Service Package customers who are adding stations or NARs a waiver of Service Charges for the additions. The customer is required to sign a 12 month or greater term agreement or be under an existing and active (not expired) term agreement with a minimum of 12 months remaining. Customers with an expired tariff agreement, or a tariff agreement expiring within the next 12 months, who renew for a 12 months or greater term, also qualify.

Promotion Specifics

- Waive Service Charges (i.e. Line Connection Charges) for Centrex NARs and Stations.
- Existing Centrex and Centrex Service Package customers are required to sign a 12 month or greater term agreement
- Existing Centrex And Centrex Service Package customers must be under an existing and active (not expired) term agreement with a minimum of 12 months remaining.
- Existing Centrex and Centrex Service Package customers with expired or expiring within the next 12 months tariff agreements must renew for a 12 months or greater term.

Promotion Restrictions/Eligibility Requirements

- Must be an existing Centrex customers with 12 months or greater remaining on their tariff agreement
- Must be an existing Centrex customers with tariff agreements that are expired or will expire within the next 12 months, who renew for 12 months or greater.
- Not available to customer with CSA, Special Assembly, or V&T agreement.
- CAN be combined with AT&T Centrex 12 and 24 Month Extension, Centrex Thank You for Renewing and AT&T Centrex Re-Term 2009 for the addition of stations and NARs.
- Does not apply to interoffice channel and bridging NRC for stations provisioned in a different wire center or different premises address.
