

TO AGRICO CHEMICAL COMPANY'S PETITION
THAT PROCEEDING BE ASSIGNED TO THE FULL COMMISSION

Tampa Electric Company replies as follows to the Petition of Agrico Chemical Company requesting that this proceeding be assigned to the full Commission:

Tampa Electric consents to the assignment of this proceeding to the full Commission. However, Tampa Electric disagrees with Agrico's assertion that the relief requested by Tampa Electric in this docket would require an existing facility to take electricity from more than one utility. It was Agrico's own voluntary decision to move a portion of its operations further south into Florida Power Corporation's assigned service territory which resulted in Agrico taking power from more than one electric utility.

WHEREFORE, Tampa Electric submits the foregoing in response to the above-described Petition of Agrico Chemical Company.


