PURPOSE

The purpose of this staff workshop is for staff to meet with the Florida Electric Power Coordinating Group, the Governor's Energy Office, the Department of Consumer Affairs/Division of Emergency Management, local government emergency preparedness officials and other interested persons to establish a workplan for the development of a Severe Weather Capacity Shortfall Emergency Plan for the State of Florida. The purpose of a Severe Weather Capacity Shortfall Emergency Plan is to establish procedures to be followed and actions to be taken by utilities and state and local emergency preparedness officials prior to and during a severe weather emergency in which electrical demand exceeds electric generating supply. Therefore, each participant should be prepared to address its respective role in the development and implementation of such a plan.
