ORDER RESOLVING PETITION FOR MODIFICATION OF ORDER NO. 11144

BY THE COMMISSION:

By Order No. 11144, issued September 7, 1982, we approved North Florida Telephone Company's (now ALLTEL Florida, Inc. or ALLTEL or Company) tariff filing to transfer service territory from its Melrose exchange to its Florahome exchange. Our approval of the tariff was conditioned on the Company's assurance that calls made by Mr. Buddy Pastor to the Melrose, Gainesville and Keystone Heights exchanges would not be charged as toll calls. Mr. Pastor, an ALLTEL customer, had based his decision to purchase real estate on representations made to him by the company that the property was in the Melrose exchange.

On August 31, 1983, the Company informed us that the necessary arrangements had been made to provide Mr. Pastor with the required service. The Company has continued to furnish service to Mr. Pastor and bill him as if he was a subscriber in the Melrose exchange.

On April 10, 1990, ALLTEL filed a petition requesting modification and/or rescission of Order No. 11144. This request was based primarily on the changes that have taken place since Order No. 11144 was issued. First, the foreign exchange (FX) line service Mr. Pastor receives is now an interLATA FX line, with higher costs associated with it. In addition, while Mr. Pastor was the only customer affected by the boundary change in 1982, there are now 15 customers within the proximity of his premises who are not receiving comparable service.

ORDERED by the Florida Public Service Commission that by ALLTEL Florida, Inc.'s voluntary withdrawal of its petition for modification or rescision of Order No. 11144, no further action is required in this docket. It is further

ORDERED that this docket be closed.
