Petitioners, as listed and identified by authorization statements attached as Exhibit "A", hereby request that the Public Service Commission establish Extended Area Service (EAS) from the Indiantown Telephone Area Exchange (Prefix 597) into the Stuart Telephone Area Exchange.

1. The proposed EAS originating in the Indiantown Telephone Area Exchange (Prefix 597) would extend to Stuart, which is the primary community of interest.

2. The petitioners in this Indiantown Telephone Area Exchange, particularly those in the northeastern tip of the area exchange including the area east of I-95 and north of State Road 714, primarily make telephone calls into the Stuart Telephone Area Exchange. Therefore, most telephone calls are long distance.

3. Petitioners request that Extended Area Service be granted which would allow them to make telephone calls into the Stuart Telephone Area Exchange without long distance charges.

4. In January 1, 1990 there were 2,326 subscribers in the Indiantown Telephone Area Exchange. Five percent (5%) of this number of subscribers is approximately 117 subscribers necessary to file this petition. Attached are authorizations statements from 154 subscribers in the Indiantown Telephone Area Exchange (Prefix 597).

WHEREFORE, Petitioners request that the Commission approve Extended Area Service from Indiantown Telephone Area Exchange (Prefix 597) into Stuart Telephone Area Exchange.

SUBJECT: DEMOGRAPHIC DESCRIPTIONS - STUART TO INDIANTOWN (I)

Local telephone service in Martin County, Florida is provided by two Telephone Companies in five exchanges. The Indiantown Telephone Company provides local telephone service in the Indiantown Exchange. Southern Bell provides local telephone service in Martin County in the Stuart, Hobe Sound, and portions of the Jupiter, and Pahokee exchanges.

Of the 160 employees at Florida Power and Light's Martin Plant in the Indiantown Exchange, only 12 live in the Indiantown community. Most of the rest live in the surrounding communities of Stuart, Port St. Lucie, Hobe Sound, Okeechobee, or in Palm Beach County. Extensive expansion is planned at this facility. By the end of the decade, full-time FPL employment at the Martin Plant is expected to reach 960. At the peak of construction in the mid-90's, 1200 construction workers will be required at the Martin Plant.

The Martin County governmental offices are located in Stuart.

Students living in Indiantown attend the South Fork schools once they progress beyond the eight grade. That school complex is located in the southern part of the Stuart exchange.

Indiantown residents would conduct most of their commercial activities in Stuart since Indiantown has not yet reached sufficient population to support many retail and service outlets.
