STATEMENT OF BASIC POSITION. Lake Worth is uncertain as to whether or not the proposed rate increase for the Large Volume Interruptible Service ("LVIS") rate class is justified. Lake Worth questions the amount of the allocation by Florida Public Utilities ("FPU") for the proposed environmental testing and remediation costs associated with the clean up of FPU's old manufactured gasplant sites at West Palm Beach and Sanford. As proposed by FPU, the total clean up costs of \$2,396,000 (preliminary estimates) will be over a 10-year period resulting in a \$239,600 charge in the CMU proposed rates. The \$239,600 is allocated using the commodity costs allocator (therms sold) which results in Lake Worth receiving EAG 43.78 percent or \$103,028 of these total environmental clean-up LIN costs. This \$103,028 charged to Lake Worth is approximately 71% 007 of the total \$144,000 rate increase to the LVIS rate class. ROS SEL
