Re: Docket No. 910394-WU; Application for Amendment of Certificate No. 106-W in Lake County to include Palisades Country Club Water System by Southern States Utilities, Inc.

Dear Ms. Schutz:

To complete the processing of the case, the following information is requested:

1. As required by Rule 25-30.036 (1) (c), Florida Administrative Code, submit a statement that the provision of service will be consistent with the water and wastewater sections of the local comprehensive plan, as approved by the Department of Community Affairs, or, if not, a statement demonstrating why granting the amendment would be in the public interest.

2. As required by Rule 25-30.036 (1) (p), Florida Administrative Code, return Certificate No. 106-W for possible amendment.

3. As required by Section 367.045 (2) (f) and Rule 25-30.030, Florida Administrative Code, provide an affidavit that noticing is complete. As discussed in a telephone conversation with Richard Redemann of this office and you, the utility has not provided notice to Utilities, Inc., the City of Groveland, and the City of Mascotte. They are within a four mile radius of the requested territory. We have attached a new four mile list with the appropriate addresses. To expedite this, you may wish to contact these entities and obtain a letter stating that they have no objection to the application.

4. As required by Rule 25-30.036, (1) (d) Florida Administrative Code, provide evidence that the utility owns the land upon which the utility's treatment facilities are located. As you explained, SSU has not closed on the property. Therefore, you should provide proof of ownership in the name of the Developer, Canam Palisades, Ltd.
