DISCUSSION OF ISSUE

ISSUE 1: Should this docket be closed?

STAFF ANALYSIS: Service evaluations were performed on pay phones operated by Charles Kaye (Mr. Kaye), in which several violations were noted. Notices requesting corrective action were sent to Mr. Kaye on requesting a response within 15 days. Mr. Kaye responded by phone within the 15 day response requirement in accordance with Rule 25-4.043 and requested additional time to correct the phones. Upon further investigation by staff, it was determined that the pay phones operated by Mr. Kaye that were cited for violations were corrected. Therefore, staff recommends that this docket be closed.
