With respect to Item No. 304, the information requested pertaining to the return on investment and net income realized by 1155 Peachtree Associates on its investment in the Campanile building in 1991 constitutes proprietary and confidential business information relating to the financial affairs of an unregulated business entity. Such financial information is considered to be a trade secret by non-publicly traded businesses. Such trade secrets are specifically considered to be proprietary and confidential business information under § 364.183, Florida Statutes.
