RE: MERGER OF THE DELTONA UTILITIES WITH SOUTHERN STATES UTILITIES, INC.

Order No. 25575, issued in Docket No. 910662-WS, acknowledged the corporate reorganization of Southern States Utilities, Inc. with the Deltona and United Florida systems. As you are aware, the merger of Southern States and the United Florida systems took place on April 1, 1992. We advised you of the Certificate activity as a result of that merger.

By letter dated July 17, 1992 (copy attached), we were advised that the Deltona systems were legally merged with Southern States on July 15, 1992. This later merger affects the following systems:

The certificates of Deltona Lakes will be canceled and the certificates held by Southern States for Volusia County (238W and 182S) will be amended to include the territory in this system. The certificates held by Marco Island will be transferred to Southern States and amended to include the Marco Shores territory. The Marco Shores certificates will be cancelled. The Spring Hill certificates will be transferred to Southern States. Please reflect these changes in the Water and Wastewater Directory. If you have any questions, please contact me.
