## CITIZENS' RESPONSE TO SOUTHERN BELL'S MOTION FOR A TEMPORARY PROTECTIVE ORDER

The Citizens of Florida ("Citizens"), by and through Jack Shreve, Public Counsel, pursuant to rule 25-22.037, Florida Administrative Code, file this response to the request for motion for temporary protective order filed by Southern Bell Telephone and Telegraph Company ("Southern Bell") on September 14, 1992.

1. Southern Bell filed its Motion for Temporary Protective Order on September 14, 1992. That motion was attached to Southern Bell's response to Citizens' Twenty-eighth Set of Interrogatories. Southern Bell seeks confidentiality for the names of employees and former employees who were disciplined, and their addresses and telephone numbers. The company's response to Citizens' interrogatories states:

Southern Bell objects to this interrogatory to the extent the information requested is proprietary. Southern Bell will provide the proprietary information to Public Counsel subject to its Motion for Temporary Protective Order being filed contemporaneously with the serving of its interrogatory response.

- 2. Southern Bell's certificate of service indicates that the motion and response were mailed to Pubic Counsel's office on September 14, 1992; however, it was not received. Southern Bell was contacted about the missing response, and the company faxed a copy to Public Counsel on September 30, 1992. However, the faxed copy did not contain the purportedly confidential information. More telephone calls were placed to the company counsel to obtain the purportedly confidential information. Company counsel stated that Public Counsel's information had actually been delivered to an inter-governmental mail box at the Public Service Commission. The confidential information was hand-delivered to Public Counsel's office on October 7, 1992. Hence, Public Counsel's response is timely.
- This issue has been fully addressed by both parties in prior motions filed in this docket. Citizens' Response to Southern Bell's Request for Confidential Classification and Motion for Permanent Protective Order filed Sept. 16, 1992; Citizens' Response to Southern Bell's Request for Confidential Classification and Motion for Permanent Protective Order filed Oct. 1, 1992. Counsel incorporates those arguments herein as support for its objection to treating the identities of disciplined employees as confidential under either section 364.183(f) or 119.07(1), Florida Statutes (1991). The identity of employees and former employees disciplined is not confidential information as the discipline administered is related to those employees duties, responsibilities, and jobs.

4. Citizens' do not object to granting temporary confidentiality to the home addresses and telephone numbers of company employees.

WHEREFORE, Citizens request this Commission to deny temporary confidential treatment to the identity of Southern Bell employees and former employees, who were disciplined in regard to matters at at issue in this docket.
