**SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S
MOTION FOR EXTENSION OF TIME IN WHICH TO IMPLEMENT
A \$.25 PER MESSAGE EXTENDED AREA SERVICE PLAN**

COMES NOW BellSouth Telecommunications, Inc., d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and files its Motion for Extension of Time in which to Implement a \$.25 Per Message Extended Area Service Plan ("Calling Plan") between the Brooksville and Hudson exchanges.

1. By Order No. PSC-92-0158-FOF-TL in this docket, the Florida Public Service Commission ("Commission") issued a Notice of Proposed Agency Action requiring the implementation of the Calling Plan between the above-referenced exchanges, which are in different LATAs ("InterLATA routes"). Southern Bell serves the Brooksville exchange. GTE Florida Incorporated ("GTE") serves the Hudson exchange. The Order required implementation of the Calling Plan within six months of April 28, 1992, the date on which the Notice of Proposed Agency Action became final.

2. On June 12, 1992, pursuant to procedures set forth by the United States District Court for the District of Columbia (the "Court") in United States v. Western Electric Company and

American Telephone and Telegraph Company, Civil Action No. 82-0192-HHG, Southern Bell filed a Motion with the District Court for waiver of the Modification of Final Judgment ("MFJ") for the purpose of implementing the Calling Plan on this InterLATA route and a request that the Department of Justice ("DOJ") concur in this motion.

3. As of the date of this filing, Southern Bell has not obtained the MFJ Waiver from the Court. Furthermore, the DOJ has issued a Report in which it recommends against the granting of an MFJ waiver. The Court, however, continues to consider Southern Bell's request for an MFJ waiver and has not yet issued an order either granting or denying this request.


4. Because Southern Bell cannot lawfully implement the Calling Plan on this InterLATA route without the MFJ waiver, it is appropriate to extend the time in which to implement the Calling Plan until after a waiver is granted by the Court. Further, if an MFJ waiver is ordered by the Court, additional time will be needed by Southern Bell to make the final preparations for implementation. Given that the construction required to implement the plan on this route is unusually extensive, approximately 120 days will be required to complete these preparations after the MFJ waiver is granted. Therefore, Southern Bell requests that the implementation date for the


calling plan on this route be postponed until 120 days after the MFJ Waiver is obtained.

WHEREFORE, Southern Bell respectfully requests the entry of an Order granting its Motion for Extension of Time to implement the Calling Plan between the above-referenced exchanges until 120 days after a waiver of the MFJ is granted by the Court.
