PURPOSE AND PROCEDURE

The purpose of this hearing is to consider Shady Oaks Mobile-Modular Estates, Inc.'s alleged violations of Commission Orders Nos. 24084 and 25296 and any motions or other matters that may be pending at the time of the hearing. The Commission may rule on any such motions from the bench or may take the matters under advisement.

In accordance with the Prehearing Order and the Order Establishing Procedure, parties shall be given the opportunity at the hearing to present testimony and other evidence on the issues identified by the parties at the prehearing conference held on November 25, 1992. All witnesses shall be subject to cross-examination at the conclusion of their testimony. Furthermore, at the conclusion of the presentation of evidence, the Commission may make a bench decision.
