**SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY'S SUPPLEMENTAL NOTICE OF INTENT TO REQUEST SPECIFIED CONFIDENTIAL CLASSIFICATION**

COMES NOW BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), pursuant to Rule 25-22.006, Florida Administrative Code, and files its Supplemental Notice of Intent to Request Specified Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") issued a Notice of Deposition in the referenced docket in order to take the depositions of Southern Bell employees on April 21, 1993, at 666 NW 79th Avenue, Miami, Florida and on April 26 and 27, 1993 at 903 West University Avenue, Gainesville, Florida. The transcribed depositions of twenty-three Southern Bell employees were received on May 21, 1993, and Southern Bell filed its Notice of Intent to Request Specified Confidential Classification of portions of these depositions on that date.


2. Southern Bell has since determined that the transcripts of depositions of two additional Southern Bell employees were


received on May 21, 1993, but that their names were inadvertently omitted from those listed in the Notice of Intent filed on that day. These employees are Frances T. Shanaver and Dinah D. Sanchez, both of whom were deposed at 666 NW 79th Avenue, Miami, Florida on April 21, 1993. Portions of the depositions of these two deponents are entitled to confidential classification for the same reasons as those set forth in the Notice of Intent filed May 21, 1993, which reasons are incorporated herein by reference.

3. Accordingly, Southern Bell hereby files this Supplemental Notice of Intent for the purpose of adding to its Notice of Intent the names of the two employees identified above.
