4. All of the information for which Southern Bell requests confidential treatment is intended to be treated as confidential, has been treated as confidential and has not been disclosed to any third party except pursuant to statutory provisions or private agreement that provides that the information will not be released to the public.

WHEREFORE, Southern Bell respectfully requests that the Prehearing Officer issue a Temporary Protective Order exempting Southern Bell's response to Public Counsel's Thirty-First Request for Production of Documents from § 119.07(1), Florida Statutes, in accordance with Rule 25-22.006, Florida Administrative Code.
