COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 1-017.4, dated May 21, 1993 - "Provide the projected expenditures for 1993 through 1996 for 800 service for BST's entire nine state region broken down into regulated and non regulated by each state."

Audit Request No. 2-098.A, dated July 2, 1993 - "Re Bellcore: Clarification to Item #11. Instead of Legislative/regulated, it should read "Washington Regulatory Support Division."
