


Please find enclosed a letter that John Clendenin, the Chairman of BellSouth Corporation, received from Commissioner Susan F. Clark of the Florida Public Service Commission, dated September 2, 1993. I also have enclosed Mr. Clendenin's response to her letter.

Commissioner Clark requested Mr. Clendenin's assistance in facilitating responses from our unregulated affiliates to NARUC's audit team in NARUC's Regional Audit of BellSouth Telecommunications, Inc. He has assured her that BellSouth is committed to cooperating with the Florida Commission as they manage the NARUC audit and the rate case which also is proceeding in Florida. Obviously, the Florida Commission and BellSouth are having difficulty in coping with NARUC's audit contemporaneous with the rate case, especially given the tight time restrictions that we face.

I would request that you also facilitate this process by assuring that the NARUC auditors are operating within the parameters of the law, the legitimate concerns of NARUC in the operations of BellSouth Telecommunications, and the instructions that you have given to them.

Where the audit team's inquiries are relevant and germane to NARUC's audit, the BellSouth companies will continue to make every effort to provide complete and timely responses.
