On October 27, 1992, P.B.V. Corporation (P.B.V.) filed a notice of abandonment of the Port Buena Vista Water System in Putnam County. The utility is a small Class C water utility serving approximately 58 residential customers and one clubhouse in Putnam County. The company began operation in March 1972. The docket was opened to monitor the abandonment of the water system by P.B.V. The notice of abandonment was withdrawn and filed again on January 14, 1993. The abandonment did not take place. Landis Enterprises, Inc. (Landis) has since acquired the utility and filed an application for a water certificate pursuant to Section 367.045, Florida Statutes, in Docket No. 930198-WU. Wastewater service is provided by a central wastewater system owned by Weber Investment Corporation (Weber). Weber has applied for a wastewater certificate in Docket No. 930197-SU.

In consideration of the above, since the abandonment of the water system by P.B.V. Corporation did not take place, no further action in this docket need be taken. Therefore, this docket is hereby closed.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
