COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued an Audit Request in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 1-147, dated August 31, 1993 - "Provide the forecast of investment which backs up the investment in Table III. Include all worksheets totalling the capital budget forecasted investment for 1991 and 1992."

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains the investment by Southern Bell for specific plant and equipment. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(e), Florida Statutes.
