through March, 1995. The period April, 1995 through March, 1996 is an overrecovery of \$270,355. A true-up refund factor of 0.967¢ per therm has been calculated.

5) As indicated in the prefiled forms, the maximum purchased gas cost recovery factor is 36.460¢ per therm for the period April, 1995 through March, 1996. This includes projected cost of gas purchased, prior period true-up, and revenue tax factors, and are based upon projected sales.

WHEREFORE, West Florida Natural Gas Company petitions the Commission to approve the foregoing purchased gas cost recovery factor, to be applied to customer bills for the period April, 1995 through March, 1996, and to billings thereafter until another purchased gas cost recovery factor is approved by the Commission.


