PREFILED TESTIMONY

NOTICE is given that, pursuant to an agreement between Staff and Gulf Power Company (Gulf), Staff hereby withdraws the testimony Michael E. Buckley filed in this docket. The purpose of Mr. Buckley's testimony was to sponsor the staff audit report of Gulf. Because Gulf has agreed to the following, that testimony is no longer needed: Gulf will adopt a policy that only meal costs incurred for an employee's own consumption will be charged to the Environmental Cost Recovery Clause (ECRC) accounts. Gulf will also remove the costs of meals previously charged to the ECRC accounts that do not meet the above policy. Gulf further agrees to stipulate the audit report into the record of the proceedings in this docket.


