Rule 25-22.006(3)(a), as amended, this filing constitutes a temporary exemption from §119.07, F.S., for the material identified by the Staff D/RR delineated above as well as the material identified in Paragraph 5 above, which the Staff obtains, as defined in Subsection (1)(e) of F.A.C. Rule 25-22.006. Furthermore, in accordance with Subsection (3)(d) of F.A.C. Rule 25-22.006, the Commission shall accord the material subject to the above listed D/RR and as described in Paragraph 5 above stringent safear rds against public disclosure.

WHEREFORE, FPL requests the Commission to treat the above-mentioned material identified as confidential in accordance with Subsection (3)(d) of Rule 25-22.006, Florida Administrative Code, as amended.
