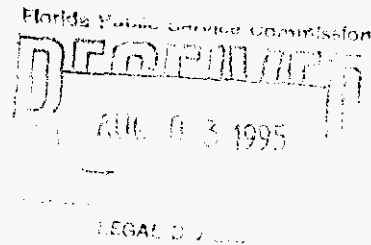

In response to your request, this letter will confirm that Southern States Utilities, Inc. ("SSU") agrees to waive the eight month suspension period set forth in Section 367.081(6), Florida Statutes (Supp.1994) for a period not to exceed thirty (30) days. SSU has filed on this date the minimum filing requirements information for its service areas in Hernando, Hillsborough and Polk Counties per the Commission's decision on August 1, 1995. Accordingly, consistent with the Commission's decision at the August 1 Agenda and pursuant to Section 367.083, Florida Statutes (1993), SSU expects that August 2, 1995 will be established as the official filing date for its Amended and Restated Application for Increased Water and Wastewater Rates, Allowance for Funds Prudently Invested and Service Availability Charges filed August 2, 1995 in the above-referenced docket.
