ORDER ACKNOWLEDGING NAME CHANGE

By letter dated August 25, 1995, Southern Pacific Telecommunications Company, holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity Number 3534, requested that Certificate Number 3534 be amended to reflect its new operating name "Qwest Communications Corporation, d/b/a Qwest Communications The Power of Connections, Inc." Upon review of the Department of State, Division of Corporations' records, it appears that Southern Pacific Telecommunications Company has properly registered the new operating name Qwest Communications Corporation, d/b/a Qwest Communications The Power of Connections, Inc. Accordingly, we find it appropriate to amend Certificate Number 3534 to reflect the new operating name.

This Order will serve as Qwest Communications Corporation, d/b/a Qwest Communications the Power of Connections, Inc.'s amended Interexchange Telecommunications Certificate of Public Convenience and Necessity Number 3534. Qwest Communications Corporation, d/b/a Qwest Communications the Power of Connections, Inc. should retain this Order as evidence of the name change.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Southern Pacific Telecommunications Company to change the name on Certificate Number 3534 from Southern Pacific Telecommunications Company to Qwest Communications Corporation, d/b/a Qwest Communications the Power of Connections, Inc. is approved. It is further

ORDERED that this change will be effective ten (10) days from the issuance of this Order. It is further

ORDERED that this docket is hereby closed.



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
