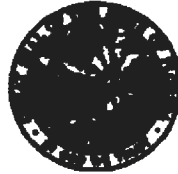

Dear Mr. Gist:

This will confirm our telephone conversation on December 6, 1995. We are in receipt of the application for nonprofit exemption that you filed. However, the application is incomplete. As we discussed we will need the following information.

1. As required by Section 367.022(7), Florida Statutes and Rule 25-30.060(3)(g), Florida Administrative Code please specify the service area.

2. As required by Section 367.022(7), Florida Statutes and Rule 25-30.060(3)(g), Florida Administrative Code please specify if the association provides water and/or wastewater service.

3. As required by Section 367.022(7), Florida Statutes and Rule 25-30.060(3)(g), Florida Administrative Code please provide articles of incorporation as filed with the Secretary of State and its bylaws. These documents must clearly show the requirements for membership, that the member's voting rights are one vote per unit of ownership, and the circumstances under which control of the corporation passes to the non-developers. Control of the corporation must pass: 1) at 51 percent ownership by the non-developers member or, 2) at some greater percentage delimited by a time period not to exceed 5 years from the date of incorporation.

4. As required by Section 367.022(7), Florida Statutes and Rule 25-30.060(3)(g), Florida Administrative Code provide proof of its ownership of the utility facilities and the land upon which the

facilities will be located or other proof of its right to continued use of the land, such as a 99-year lease. The Commission may consider a written easement or other cost effective alternative. If the association does not own any land, please state this.

We have attached a copy of your application, and a new application for your convenience.

Also, the application must be signed by a officer of the corporation, or a letter must be provided from an officer of the corporation giving you the authorization to sign the application.

Please file an original and four copies of the requested information no later than January 19, 1996 with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, FL 32399.
