1	Q.	PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.		
2	Α.	My name is Joseph P. Cresse and my business address is 215 S. Monroe		
3		Suite 701, Tallahassee, Florida 32302-1876.		
4	Q.	PLEASE STATE YOUR OCCUPATION.		
5	A.	I am a non-lawyer consultant working for the law firm of Messer, Caparello		
6		Madsen, Goldman & Metz, P.A.		
7	Q.	WOULD YOU DESCRIBE YOUR BACKGROUND AND EXPERIENCE?		
8	A.	Please see Exhibit JPC-1 attached to my testimony.		
9	Q.	FOR WHOM ARE YOU TESTIFYING IN THIS DOCKET?		
10	A.	I am testifying on behalf of Florida Cable Telecommunications Association.		
11	Q.	WHAT IS THE PURPOSE OF YOUR TESTIMONY?		
12	Α.	The purpose is to recommend the appropriate policy the Commission		
L3		should adopt in setting interconnection charges for local traffic between		
L4		Alternative Local Exchange Companies (ALECs) and incumbent Local		
L5		Exchange Companies (LECs) and the appropriate compensation LECs and		
L6		ALECs should pay for terminating local traffic between themselves.		
L7	Q.	WHAT ARE THE APPROPRIATE POLICIES THE COMMISSION SHOULD		
18		KEEP IN MIND AS THEY CONSIDER AND DECIDE INTERCONNECTION		
L9		ISSUES?		
20	A.	I believe many are outlined in SB 1554 and can be summarized as follows:		
21		1. The competitive provision of telecommunication services including		
22		local service is in the public interest.		
23		2. Encourage competition in order to ensure the availability of widest		
24		possible range of consumer choice.		
25		3. Promote competition by encouraging new entrants into		

1		telecommunication markets.
2		In addition, I believe the Commission should keep in mind the following:
3		1. Flat rate pricing for subscribers of local service and usage sensitive
4		pricing for interconnection are not compatible, and could inhibit the
5		provision of competitive local services to all consumers. The goa
6		in this and all other implementation issues before the Commission
7		should be to encourage competition for all consumers, not jus
8		those who receive more calls than they originate.
9		2. If possible, the interconnection policy approved by the Commission
10		should not impose additional costs on the industry as a whole.
11		3. The ALECs and LECs should be treated as co-carriers and not as
12		customers, and the policies governing the exchange of traffic
13		between local exchange companies should also be applicable to
14		ALEC and LEC interconnection.
15	Q.	WHAT IS THE APPROPRIATE COMPENSATION PLAN FOR
16		TERMINATING LOCAL CALLS?
17	Α.	The plan that would promote and encourage competition for all consumers
18		regardless of that consumer's calling pattern and which imposes the least
19		incremental cost to all local exchange companies. The plan is called Bill
20		and Keep or Payment in Kind. Others may call it something else.
21	Q.	WHAT ARE THE ADVANTAGES OF THAT TYPE OF SYSTEM?
22	A.	There are several advantages, but those that come to mind are:
23		1. Avoidance of the incremental cost of recording, billing,
24		collection, auditing and dispute resolution, none of which
25		contributes to more efficient delivery of services.

1		2.	Bill and Keep - Payment in Kind encourages LECs and
2			ALECs alike to want to serve all potential customers,
3			without considering whether their usage is predominately
4			originating or terminating traffic. Any charge for terminating
5			calls provides an incentive to serve customers who receive
6	·• *		more calls (airline reservation), than those who generally
7			place more calls that they receive (residential).
8		3.	I believe the Commission is well aware of the LECs' desire
9			to encourage Local Measured Service, and a measured rate
10			for terminating local calls could be the first step in a long
11			journey to local measured rates. Flat rate pricing and usage
12			based terminating charges appear to be incompatible.
13	Q.	ARE THERE	OTHER REASONS A BILL AND KEEP-PAYMENT IN KIND
14		MECHANISM	SHOULD BE ADOPTED?
15	A.	Yes, if comp	etition is successful, over the long term the terminating
16		minutes of us	e between ALECs and LECs should balance out. Bill and
17		Keep-Paymer	nt in Kind provides an incentive for each carrier to minimize
18		their terminati	ng costs, and it also has the advantage of eliminating the
19		need for any a	additional cost studies and the litigation expenses attendant
20		thereto.	
21	Q.	DOES THIS C	CONCLUDE YOUR DIRECT TESTIMONY?
22	A.	Yes. My testi	mony is brief, but I deliberately kept it that way to save the

Commission's time.

JOSEPH P. CRESSE

Presently employed as a non-lawyer Special Consultant with the law firm of Messer, Caparello, Madsen, Goldman & Metz P.A. in Tallahassee, Florida; former Chairman of the Public Service Commission having served seven years on the Commission; former State Budget Director for State of Florida under Governor Reubin Askew, and former Assistant Secretary for the Department of Administration, State of Florida.

Resides in Tallahassee, Florida, with wife, Beverly; has two children; born in Indiana, and attended public schools in Frostproof, Florida; attended University of Florida - graduated in 1950 B. S. B. A. Major in Accounting; served in the U. S. Army as Staff Sergeant; member of Beta Alphi PSI Fraternity.

Career accomplishments include recipient of Florida Senate and House Resolution of Commendation; Administrator of the year in 1975; recipient of University of Florida Distinguished Alumnus Award; served on the Executive Committee of National Assn. of State Budget Officers, National Assn. of Regulatory Utility Commissioners, and President of the Southeastern Assn. of Regulatory Utility Commissioners; assisted in passage and implementation of the Career Service System, State of Florida; assisted in the implementation the Governmental Reorganization Act; implementation of program budgeting and computerizing substantial budgeting information; assisted in development of Education funding program for the State of Florida; assisted in development of financial plan to reduce appropriations to operate within available funds when revenue of the State was approximately 10% less than anticipated; assisted the Governor and Legislature during Special 1978 Legislative Session in drafting and passing legislation protecting title to state sovereign lands; served as member of the Florida Advisory Council on Intergovernmental Relations; appointed by Governor as member of the Deferred Compensation Advisory Committee and elected chairman; chaired a Task Force which developed financial and organizational plans to dismantle the Inter-American Center Authority with real estate assets of the Authority preserved for public use; appointed by Governor to state team which successfully negotiated a major settlement involving oil, gas and mineral rights on state-owned submerged lands; appointed to task force overseeing litigation, State v. Mobil Oil. Sovereign Lands; member Growth Management Committee; appointed by Governor and co-chaired Telecommunications Task Force. In 1985 received the National Governor's Association award for Distinguished Service to State Government. Retired from State Government December 1985 to assume present position with Messer, law firm. Since 1985 he has been engaged in regulatory consulting work with both utilities and non-utilities. He lectures at Indiana University once a year, and has testified before the Georgia, Florida, South Carolina and Virginia Regulatory Commissions.
