3 investor-owned electric utility shall maintain its accounts and
4 records in conformity with the ~~Federal Energy Regulatory~~
5 ~~Commission's~~ Uniform System of Accounts (USOA) for Public Utilities
6 and Licensees as found in the Code of Federal Regulations, Title
7 18, Subchapter C, Part 101, for Major Utilities as revised April 1,
8 1995, 1987 and as modified below. All inquiries relating to
9 interpretation of the USOA ~~Uniform System of Accounts~~ shall be
10 submitted to the Commission's Division of Auditing and Financial
11 Analysis in writing.

12 (2) For ratemaking purposes only, each investor-owned
13 electric utility shall accrue unbilled base rate revenues,
14 excluding those base rate revenues recoverable through other cost
15 recovery or adjustment mechanisms.

16 (3) Each utility shall establish and maintain continuing
