BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Tele-Pro Communications, Inc. (TPC) holds Certificate No. 3483 to provide interexchange telecommunications service. On January 24, 1995, TPC filed a request to change the name on its certificate to Petracom Corporation. Our staff investigation showed that TPC did not register the name Petracom Corporation with the Secretary of State and did not file a tariff with the new name. The company's consultant informed our staff that TPC could not register the name and the company did not intend to pursue the name change. Because TPC did not file a withdrawal of its request, we deny the request for a name change and close this docket.

It is, therefore,

ORDERED by the Florida Public Service Commission that Tele-Pro Communications, Inc.'s request for a name change is hereby denied. It is further

In the absence of such a petition, this order shall become effective on the day subsequent to the above date as provided by Rule 25-22.029(6), Florida Administrative Code.

Any objection or protest filed in this docket before the issuance date of this order is considered abandoned unless it satisfies the foregoing conditions and is renewed within the specified protest period.

If this order becomes final and effective on the date described above, any party substantially affected may request judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or by the First District Court of Appeal in the case of a water or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days of the effective date of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
