On February 23, 1996, GTE Card Services Incorporated filed a tariff revision which, among other things, reflects that GTE Card Services Incorporated now uses the fictitious name GTE Card Services Incorporated d/b/a GTE Long Distance in Florida. GTE Card Services Incorporated d/b/a GTE Long Distance will reflect this name change on its tariff pages using labels, a practice that the Commission has accepted in the past. Those labels have been delivered directly to Mr. Jeff Bates.

The use of the fictitious name GTE Card Services Incorporated d/b/a GTE Long Distance is only a name change, and does not involve any change in majority organizational control or other change in ownership. Proof of registration of the fictitious name with the Florida Secretary of State is attached as "Composite Exhibit A."
