the attached letter.

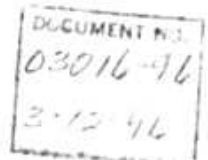
Expedited disposition of the Joint Petition by the PSC in this

On January 12, 1996, you received the Compliance Agreement to resolve violations at the Flagler County Airport public drinking water system.

You were requested to review the document, and if acceptable, sign and return the original document to this office within 14 days of receipt. If the Compliance Agreement was not acceptable as written, you were asked to respond in writing within 14 days explaining the problems which you have with the document.

As you are aware, in order to resolve the violations, you must either enter into a Compliance Agreement or settle the case in a judicial proceeding.

To date, the Department has not received any correspondence from you concerning this case. Unless a notice stating your intentions is received by February 16, 1996, the Department will be forced to seek a judicial resolution.
