## BELLSOUTH TELECOMMUNICATIONS, INC.'S PARTIAL WITHDRAWAL OF MOTION FOR RECONSIDERATION

COMES NOW, BellSouth Telecommunications, Inc. ("BellSouth"), and files its Partial Withdrawal of the Motion for Reconsideration of Order No. PSC-96-0444-FOF-TP, filed on April 12, 1996 in the above captioned docket. In support of its Partial Withdrawal, BellSouth states the following:

1. On March 29, 1996, the Florida Public Service Commission ("Commission") issued Order No. PSC-96-0444-FOF-TP ("Order") in this docket. The Order, among other things, required BellSouth to provide a 2-wire voice grade loop at an interim rate of \$17 per month and a 2-wire analog port at an interim rate of \$2.00 per month.

2. On April 12, 1996, BellSouth filed its Motion for Reconsideration of the Order, arguing that the \$17.00 price set by the Commission for the 2-wire voice grade loop was below the cost produced by BellSouth at the hearing of this matter. Moreover, BellSouth argued that the \$2.00 price set for the 2wire analog port contained a minute contribution to shared and common costs or to universal service.

3. In the Order, the Commission required BellSouth to perform new cost studies for the 2-wire voice grade loop and 2-

The new cost study for the 2-wire voice grade loop indicates that the price set by the Commission is above cost. The new cost study for the 2-wire analog port indicates the price set by the Commission contains some contribution.

4. Accordingly, BellSouth hereby withdraws the part of its Motion for Reconsideration, filed on April 12, 1996, concerning the price of the unbundled 2-wire voice grade loop. BellSouth also withdraws part of its Motion for Reconsideration regarding the price of the 2-wire analog part. BellSouth does <u>not</u> withdraw that part of the Motion concerning the need for a usage rate in addition to the rate for the "hardware" of the port.
