- 3. The information at issue details the number of customers who have taken various optional extended area service plans. The information is broken out to show the number of both residential and business customers, the specific plan that these customers have chosen and the particular routes involved. This type of service is, of course, subject to competition.
- 4. This information clearly constitutes sensitive business information. If it were publically disclosed, the competitors of BellSouth could utilize this information to target their marketing efforts toward certain BellSouth customers.
- 5. For these reasons, the public release of this information would obviously work to the detriment of BellSouth. Section 364.183(3)(e) states specifically that "information relating to competitive interests, the disclosure of which would impair the competitive business of the provider of the information" is entitled to confidential classification. The above-described information is precisely this type of information. For this reason, the above-described information is entitled to confidential classification.
- 6. The information for which confidential treatment is requested is intended to be and is treated as confidential by BellSouth and has not been disclosed to the public.

WHEREFORE, BellSouth respectfully requests confidential classification for the above-described information.
