Having first consulted with Mr. Twomey, counsel for Citrus County, regarding the matter, I am using this means to correct a factual error in Citrus County's response to the Petition to Intervene we filed on behalf of Marion Oaks Homeowners Association and the City of Keystone Heights in the above docket.

In the response, Citrus County states, inter alia, that the Commission's decision to allow Marion Oaks and the City to intervene in SSU's pending rate case, Docket No. 950495-WS, was based on the existence of special funding arrangements established by the Office of Public Counsel that are unique to that docket and are inapplicable to Docket No. 920199-WS.

This statement is in error. Marion Oaks' and Keystone Heights' joint petition to intervene as parties was submitted in Docket No. 920199-WS pursuant to the same initiative and funding arrangements by the Office of Public Counsel that serve as the basis for their intervention and participation in Docket No. 950495-WS.
