Re: Docket No. 960699-WS; Application for Amendment of Certificates Nos. 511-W and 467-S by Spruce Creek South Utilities Inc. in Marion County.

Dear Mr. Deterding:

After reviewing the application in the above referenced docket, the staff has identified the following deficiency:

1. As required by Section 367.045(1)(a), Florida Statutes (F.S.), and Rule 25-30.030, Florida Administrative Code (F.A.C.), the utility must provide notice of the application and provide affidavits that the notice was given. The notice must be given to the governmental entities and all utilities in the county, all cities located in the county, and to each of the customers in the proposed territory. The notice must be published in a newspaper. We have received the affidavit for noticing the utilities and governmental entities. The application stated the newspaper publication affidavit would be a late filed exhibit. Please file the affidavit when the noticing is complete.

In addition, staff has a question concerning the territory description. As we discussed earlier, I believe Call No. 11 does not reflect the territory on the map. Call 11 stated - Also the South 1/2 of the NE 1/4 of the NW 1/4, of Section 16, Township 17 S., Range 23 East, except those lands lying within the Rights of Way of State Road 500 - U.S. 441 (200 feet wide). The area in question is a small triangular area in the NW 1/4 of the NE 1/4. I previously sent you a copy of the map where the area is question. Please advise if the map is incorrect or if the utility plans to renotify the territory.
