

Re: Docket No. 941044-WS, Resolution of Board of County Commissioners of Charlotte County Declaring Charlotte County Subject to the Provisions of Chapter 367, Florida Statutes - Request for non-jurisdictional finding for provision of water service by PRICE SANDERS SCOUT RESERVATION

An application for a non-jurisdictional finding was recently filed with the Commission on behalf of Price Sanders Scout Reservation by Mr. B. L. Pratt. However, the form must be signed by an "owner." In this case, an owner would be a corporate officer of Southwest Florida Council, Inc. I am attaching a revised form for signature by an officer of the Council as well as a copy of the original filing.

There is one other issue that needs to be resolved with regard to the application. Commission orders can only be issued to entities properly registered with the State. The Southwest Florida Council is properly registered as a Florida corporation. However, Price Sanders Scout Reservation is not registered as a fictitious name for the Council. You need to contact the Florida Department of State, Division of Corporations at (904) 488-9000 to request forms to register a fictitious name. Please include a copy of your filing for a fictitious name along with the revised application.
