COMES NOW BellSouth Telecommunications, Inc. ("BellSouth" or "Company"), and files, pursuant to Rule 25-22.006(5)(c), Florida Administrative Code, its Motion for Temporary Protective Order in connection with its Responses to Office of Public Counsel's ("Public Counsel") First Set of Post-Settlement Interrogatories (1995 Earnings) dated June 5, 1996.

On July 10, 1996, BellSouth filed its Responses to Public Counsel's First Set of Post-Settlement Interrogatories, portions of which are deemed to be confidential and proprietary by Southern Bell. Some of the information that will be conveyed to and reviewed by Public Counsel in connection with the responses to these interrogatories contain proprietary, confidential business information which should not be publicly disclosed. Thus, pursuant to the Commission's Rule on confidentiality, Rule 25-22.006(5)(c), Florida Administrative Code, BellSouth moves that the Prehearing Officer issue a Temporary Protective Order exempting these documents from § 119.07(1), Florida Statutes. The proprietary information in question includes, but is not limited to, information concerning settlements of lawsuits and other claims, as well as information concerning unregulated operations.
