NOTICE OF INTENT TO REQUEST CONFIDENTIAL CLASSIFICATION

The Southern Company and Southern Development and Investment Group, Inc., an associate company of Gulf Power Company, by and through its undersigned attorney and pursuant to Rule 25-22.006, Florida Administrative Code, hereby gives notice that it intends to request confidential classification for certain information, hereafter the Certificate, submitted to the Florida Public Service Commission Staff pursuant to Securities and Exchange Commission Rule 53(a)(4), C.F.R. §250.53(a)(4). A copy of the Certificate is attached hereto as exhibit "A". Rule 53 requires that every registered holding company submit certain specified categories of filings to each state commission in which the affiliates of the registered holding company operate. Gulf Power is an affiliate of the Southern Company, a registered holding company.

The Certificate contains proprietary and commercially sensitive information regarding the Southern Company and Southern Development and Investment Group, Inc. and certain of its unregulated, non-utility, businesses and investments which would cause irreparable harm to the Companies if disclosed to the general public. A formal request for confidential classification will be filed within the time period specified in Rule 25-22.006(3)(a), Florida Administrative Code, if




