CASE BACKGROUND

On March 29, 1996, this Commission received an application from Glenn's Cove Central Water System (Glenn's Cove) for approval of the transfer of its facilities to the City of Tavares (the City) pursuant to Section 367.071(4)(a), Florida Statutes, and Rule 25-30.037, Florida Administrative Code. The transfer was to have occurred on June 4, 1996. Purguant to Section 367.071(4)(a), Florida Statutes, the transfer must be approved as a matter of right.

On June 17, 1996, Order No. PSC-96-0782-FOF-WU was issued acknowledging the transfer and cancelling Certificate No. 324-W. The transfer did not occur on June 4, 1996 as planned. The parties have indicated that the transfer will not occur at anytime in the Therefore, Staff has reopened the docket to bring this recommendation to vacate Order No. PSC-96-0782-FOF-WU and reinstate Certificate No. 324-W.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission vacate Order No. PSC-96-0782-FOF-WU
and reinstate Certificate No. 324-W?

RECOMMENDATION: Yes. Order No. PSC-96-0782-FOF-WU should be vacated and Certificate No. 324-W should be reinstated. (REYES)

STAFF ANALYSIS: As previously discussed in the Case Background, Glenn's Cove applied for approval of the transfer of its facilities to the City of Tavares pursuant to 367.071(4)(a), Florida Statutes, and Rule 25-30.037, Florida Administrative Code. That transfer was approved as a matter of right by Order No. PSC-96-0782-FOF-WU. By that same order, Certificate No. 324-W was cancelled.

Approximately June 26, 1996, Staff was put on notice by the City that the transfer had not occurred on June 4, 1996 as planned because the City decided to rescind the sales contract via a feasibility clause in the agreement. Because the transfer did not occur, Glenn's Cove remains subject to this Commission's jurisdiction. Therefore, Staff recommends that Order No. PSC-96-0782-FOF-WU be vacated and Certificate No. 324-W be reinstated.
